## Interested in a role with the Provincial Dental Board of Nova Scotia?

The Government of Nova Scotia has asked the NSDA to communicate to its members the upcoming opportunity to apply for a government-appointed seat at the Provincial Dental Board of Nova Scotia. Currently, both the NSDA and government appoint dentists to the board. This opportunity is for the government-appointed seats. Interested applicants are asked to apply via the following link and information:

This is a secure system that requires you to first login using the Nova Scotia Login System. If this is your first time using the NS Login System you will be asked to create an account and then login.

Once you login you will be redirected back to Online Applications to ABCs:

You will be asked if you already have an account or if you need to create an account. The Nova Scotia Login system is used by all government departments to conduct business transactions so there are a number of people who already have accounts. If an Applicant does not have an existing account, they will be asked a series of questions. After completion, an Applicant will have a username and password.

The first step is to create a profile and fill in the information on the Your Profile page.
