Advisory from the Provincial Dental Board Executive — November 25, 2020

The Provincial Dental Board of Nova Scotia issued guidance clarifying the difference in protocols for staff and patients who were in a bar or restaurant in HRM after 10 pm in the past two weeks versus staff and patients who visited locations listed on the possible COVID-19 exposure site during specified times.

New COVID-19 Government Supports

Bill C-9: The Act to amend the *Income Tax Act* achieved Royal Assent on November 19, 2020. The measures adopted as part of Bill C-9 include the following:

- Canada Emergency Rent Subsidy (CERS) will provide direct and
 easy-to-access rent and mortgage interest support to tenants and
 property owners until June 2021 for qualifying organizations affected by
 COVID-19. The new CERS will support businesses, charities, and nonprofits that have suffered a revenue drop by providing support up to a
 maximum of 65% of eligible expenses until December 19, 2020. Claims
 can be made retroactively to September 27, 2020. Applications are now
 open.
- New Lockdown Support will provide an additional 25% through the CERS for qualifying organizations that are subject to a lockdown and must shut their doors or significantly restrict their activities under a public health order issued under the laws of Canada, a province or territory.

Combined, this will mean that hard-hit businesses subject to a lockdown could receive rent support of up to 90%.

Extension of the Canada Emergency Wage Subsidy (CEWS) until
June 2021, which will remain at the current rate of up to 65% of eligible
wages until December 19, 2020.

CDA is looking to update federal funding program information on its website as soon as feasible.


