## LAST CALL — MSI Children's Oral Health Program Survey

Last month, the NSDA held a virtual "town hall" event to provide an opportunity for membership to air concerns over the current state of the MSI Children's Oral Health Program (COHP). There were many possible collective actions

proposed, and chief among them was the suggestion that the NSDA needs to determine the level of impact the current program tariff has on dental practices before proceeding further. The NSDA Table Officers Committee has developed the following survey and hopes all members will take a few minutes to complete it. The deadline to complete the survey is the end of the day on Saturday, Oct. 31, 2020.

Important Safety Information on Benzocaine-Containing Products and the Risk of Methemoglobinemia in Children under Two Years of Age

Benzocaine has been associated with methemoglobinemia (MetHb), a serious,

potentially life-threatening adverse reaction. Health Canada is concerned that children under 2 years of age may still be given benzocaine-containing products despite previous warnings concerning this health risk. Healthcare professionals are reminded to NOT recommend benzocaine-containing products for children under 2 years of age.
